NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Fastbrick Robotics Limited (ASX:FBR) ("FBR", "Company" or "Fastbrick Robotics") further to the announcement on 9 December 2016 confirming a strategic and cornerstone investment by Hunter Hall Investment Management Limited, the Company confirms that on 13 December 2016 it completed the issue of 98,765,432 fully paid ordinary shares (Shares) in the capital of the Company. The Shares were allotted at \$0.081 per share and has raised a net total of \$8,000,000.
